

<u>CHRISTIAN EDUCATION MINISTRY TEAM</u> – Mary Ann Patterson, Chairperson 2014 Year End Report

The mission of the Christian Education Committee is to provide opportunities for learning about the Word of God to the congregation as a whole.

Anne Brienza served as CE Director full time during 2014.

Following are some of the events that took place within the church family during 2014:

- Youth Fundraising/Mission Trip A Sub Sandwich sale was held in February, St. Patty Day Luncheon and auction on March 16. The Kroger Community Rewards program also supported Youth Mission Trips. Eight High School students traveled to Webster Springs, WV June 8-14. Seven MS students went to Sandusky for a total of 4 days.
- Held Church Family Night (CFN) February 5 through March 9. No CFN during the fall. Held Wednesday rehearsals to prepare for "Good King Wenceslas" musical presented during the December 7 worship. 20 children participated. In the fall, Tween Club was developed on Wednesdays for 4th and 5th graders.
- Held 9 "Kids Night Out Parent's Night Off" on Friday's. Bible Stories, crafts and games. Well-attended ranging from 17 to 32 in attendance.
- "Jungle Safari" was the Vacation Bible School theme in August. 64 Total attended, along with 12 MS/HS Youth Leaders. Kids were bussed to Kirkmont. A half day preschool was added and held at the church with 10 participants. A summarized evaluation was completed to consider for next year.
- Continued effort to raise money in support of Kirkmont Center. Through VBS, Mission Ministry team, Women's Association and CE's fundraising dinner, a total of \$5,504.68 was raised. Held 2 workdays with several adults and kids working on clean up and projects.

CHRISTIAN EDUCATION MINISTRY TEAM cont.

- Youth Fellowship activities for both Middle School and High School were held throughout the year with fluctuating participation, as well as a January Lock In.
- Continued 4 Adult Sunday School classes with high attendance and participation.
- Bibles were presented to 2nd graders.
- Building Blocks were presented to 40 SS children/youth for achieving Building Block goals. Continued Adult Building blocks and presented a certificate for completion to 17 adults, along with a spaghetti recognition dinner.
- Mothers and Fathers were honored with small gifts on their special days.
- Graduation Sunday and Coffee hour with Bibles presented to 5 HS Seniors.
- Recognized Sunday School teachers.
- Invited college students to a Sunday School Brunch during Christmas break.
- Prepared for a Live Nativity during the city Christmas Parade but was cancelled due to weather and will be considered next year.

The Committee would like to thank all volunteers who helped to support these activities. The success of the CE committee is totally dependent upon the participants and leaders of these activities.

The last year proved to be another successful year in helping others for our church family. We started the year with the "One Great Hour of Sharing" program that raised \$2,463.92 for world and local mission.

We supported 17 families and 48 children with our Sharing Tree program. This program is our school-aid effort that provides school bags, school supplies and shoes for those that need it the most. This is one of the best ways to help our youth get better prepared for the upcoming school year. By your efforts, this helps lessen the stress on families to provide their kids with the necessary supplies to kick off the school year right!

The 2014 Holland Theater Cruise-In fundraiser was another success. As our downtown fills with antique and classic cars, our church volunteers provide a fantastic opportunity for good food and drink. This is one of our more entertaining tasks we do every year. It is also a fundraising opportunity to do more missions. This year, the committee voted to allow a portion of this event's income to help our volunteers travel to New Jersey for a mission trip to rebuild a portion of the community ravaged by a hurricane. We raised \$775.87 for this event!

Projects Completed in 2014:

- Cleaning of Bell Tower
- Replaced Sanctuary Air Conditioning compressor
- Replaced electric panel for boiler pumps to properly handle the load
- Boiler pump repairs and other misc. repairs
- Replaced carpeting on columns in gym due to wear and to match new color scheme
- Deterred roosting and nesting of pigeons in bell tower by covering openings and installing sonic repellant
- Patching of roof leaks (Lee's Roofing warranty work)

We also need to recognize the wonderful volunteer efforts of Art Lloyd in installing new windows in the courtyard/corridor wall. This has significantly brightened up this area and improved the thermal performance of this wall. Art has also begun the first phase of the beautification of the courtyard into a Memorial Garden by installing a fence to screen of the A/C condensing unit. He has also assisted Ralph with other maintenance and improvement projects around the church.

Ralph Morrison continues to do a yeoman's job in keeping our facilities maintained, repaired, cleaned, and ready for every service or event.

Looking ahead to 2015

Our wonderful old masonry building requires ongoing maintenance to keep us all dry and warm. The masonry itself requires periodic re-pointing and sealing. We will need to address the areas of greatest need on an annual basis to be able to properly maintain the structure while staying within our budget. Currently the east wall / Main Street entrance area and portions of the Bell Tower are in the greatest need of attention to prevent and further deterioration.

STEWARDSHIP AND FINANCE MINISTRY TEAM – Eric Adelsberger, Chairperson

- 2014 members include: Eric Adelsberger, Mike Brady, Sue Dearwester, Bridgett Hawkins, Jim Hilliker, Vance Holloway, Steve Mast, and Jeanne Zupp. Julie McCarthy, Church Secretary, served the committee as Financial & Recording Secretary and also prepared agendas and financial reports for our meetings. Rev. Rob Fulton also attended, participated, and provided guidance during our meetings.
- On February 15, 2014 our team met and performed the Annual Church Audit for the prior year 2013. All records reviewed by the Audit Committee were well organized and found to be in good order. There were no items of concern noted during the review that needed to be addressed through written comments or that require follow up action.
- Our team met on a monthly basis with only a few exceptions during the year. During our meetings we routinely reviewed the revenues and expenses for First United Presbyterian. We compared the actual revenues and expenses with budgeted and/or expected amounts. During the summer months actual giving began to lag behind pledged giving noticeably. Our committee monitored actual giving versus pledged giving closely for the remaining portion of 2014 and reported to session monthly. A financial recap of 2014 activities as compared to the three prior years is as follows:
 - \circ 2014 pledges = 91 pledges received = \$227,840.00, total GF giving = \$278,446.23
 - 2013 pledges = 95 pledges received = \$ 225,172.00, total GF giving = \$ 275,196.56
 - 2012 pledges = 107 pledges received = \$ 244,296.50, total GF giving = \$ 291,961.89
 - 2011 pledges = 111 pledges received = \$ 253,694.00, total GF giving = \$ 302,323.73
- During the Fall of 2014 our team presented the 2015 stewardship campaign, "<u>Thank you</u> for your Faithfulness to Christ's Church". 2015 monetary pledges total \$222,324. 92 pledges were received, 30 were increases, 38 remained the same, and 14 decreased, and 10 were new pledges.
- During the month of December our committee prepared a budget for the 2015 calendar year that will be presented to Session on January 7, 2015.

The Stewardship and Finance Committee would like to thank the members and friends of First United Presbyterian for their continued faithfulness in the life and work of this Church. It is our privilege and pleasure to serve God, this Church, and each of you through our work.

The Endowment Fund Committee is responsible to receive donors' gifts to the church, insure that the wishes of the donors are honored, and to invest those funds with a priority of principal preservation and competitive interest return. To implement this conservative investment philosophy, the committee, over the past twenty years, has consistently invested the majority of the Fund in medium and long-term United States Government Bonds. This has provided a steady interest return and insured principal preservation. Beginning in 2013, the committee expanded its conservative bond investment philosophy to include high-grade, AAA rated, general obligation municipal/county/state bonds. The market value of our bonds continue to exceed the face value. As of 12/31/2014, the obligations of the Endowment Fund (principal and accumulated interest) were \$1,220,691.31. As of the same date the market value of the Endowment Fund was approximately \$1,290,660.02, resulting in a market surplus of \$69,968.71.

During 2014, the Endowment Fund earned an average of 5.32% interest. This interest is comprised of 5.76% for funds under the investment management of the committee and 2.48% for gifts of specific assets. The 5.76% return in 2014 is due partially to the receipt in 2014 of \$6,008.00 of 2013 interest. Without this one-time event, the funds under the investment management of the committee would have earned 5.17%.

Programs supported by the Fund's interest continue to include our Church's Sharing Fund, our Christian Education Program, and the Scholarship Program of our church. \$20,000 was granted to college scholarship recipients in 2014.

Gifts can be donated to our church through the Endowment Fund in three ways: restricted principal and restricted interest, restricted principal and non-restricted interest, non-restricted principal and non-restricted interest. All members of the congregation are encouraged to use the Endowment Fund to make contributions that will provide long-term benefits to the program life of our church.

The motion was approved without opposition.

Moderator Fulton returned and asked if there were any other items from the report that needed discussion, or any other items to bring before the congregation. There being no further business to come before the congregation, the Moderator said that the Annual Report provides only a glimpse of who we are and the many things that we do and thanked everyone for their efforts and involvement in our church. Moderator Fulton closed the meeting with prayer and returned to the worship service.
