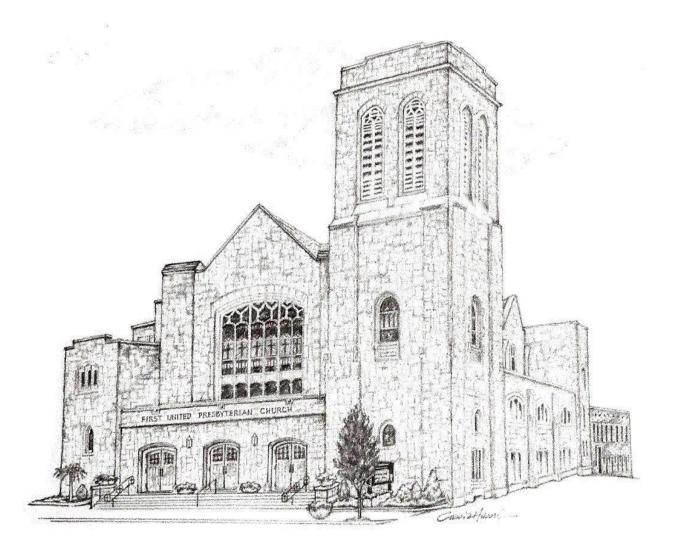

THE ANNUAL CORPORATE AND CONGREGATIONAL MEETING FIRST UNITED PRESBYTERIAN CHURCH

January 29, 2023

The annual corporate and congregational meeting was held on January 29, 2023, after the church worship service. Written notice was given two (2) weeks prior to the meeting. A quorum was declared.

Pastor Steve Merrin opened the meeting stating the purpose to report on the budget, approve his terms of call, and provide the annual report to the congregation.

The annual report included minutes from the congregational meeting of 2022, membership statistical report, list of staff, elders and deacons, summaries from all standing committees, deacons, PWA, nominating committee and the scholarship report. A motion was made by Anne Brienza and seconded by Ranae Lentz to approve the annual report. The motion passed.

Bridget Hawkins, Chairperson of the Stewardship and Finance Committee addressed the congregation. Provided in the annual report was the 2022 and 2023 operating budget. Bridget reported that we received 49 pledges and thanked the congregation for their continued support of the church. A motion was made by Gary McKenzie and seconded by Jack Costin to approve the budget. The 2023 operating budget was approved by the congregation.

Pastor Steve Merrin left the meeting so that his terms of call could be discussed by the congregation. Chairperson Hawkins went over the Pastor's terms of call and explained that an increase to his salary was recommended by the Stewardship & Finance Committee and had been approved by the session. Bridget also stated that Pastor Merrin had not received an increase since his initial terms of call were approved. No questions were asked by the congregation. A motion was made by Mary Jane Lane to approve the Pastor's Terms of Call and seconded by Becky Weber. The motion passed.

Pastor Steve Merrin returned to the meeting and explained that no further business was needed and asked for a motion to adjourn. Kyle Lentz moved to adjourn the meeting which was seconded by Pat Ortli. Meeting adjourned and Pastor Merrin closed with prayer.

First United Presbyterian Church Annual Fall Congregational Meeting Minutes October 29th, 2023

The First United Presbyterian Church held it's Fall Congregational meeting. Notice had been for 2 weeks prior.

Call to Order: Rev. Kathleen Burslem called the meeting to order and declared a quorum. She opened the meeting with prayer.

Purpose of the meeting: Rev. Burslem stated the purpose of today's meeting is to request a change to the churches by laws and to elect our elders and deacons for the class or 2026 and to elect the members of the congregation to the nominating committee for 2024.

Proposed By-Law change: Elder Mark Butler, chairperson of the Nominating Committee presented the proposed by law change. Currently our by laws allow for an elder or deacon to be elected for a three-year term. No elder or deacon shall serve on their respective board for consecutive terms, either full or partial, aggregating more than 54 months; but shall again become eligible to be elected to a new term after one year shall have elapsed.

The request is to change our by-laws will match the Presbyterian Book of Order. An Elder or Deacon will be elected to serve terms of no more than 3 years and may be eligible for re-election but may not serve more than 6 consecutive years. A ruling elder or deacon who has serve 6 years shall be ineligible for the same board for at least one year.

There was a motion and a seconded to make the change. Good questions were asked and responded to. When there were no other questions or discussion, Pastor Burslem called the motion to vote and the motion passed.

Elders, Deacons, & Nominating Committee: Elder Mark Butler presented the recommended list of Deacons for the class of 2026: Betty Lloyd, Ben Stahler, Elaine Thompson, & Judy Wical. The list for Elders for the class of 2026: Karen Brady, Carla Murdock & Bill Wical. The members of the congregation for the 2024 nominating committee: Sue Dearwester, Bridget Hawkins, Edson Jenkins, and Nancy Stokes.

Rev. Burslem asked if there were any other nominations and reminded to nominate someone you must have secured their permission. There were no nominations and a motion was made and seconded to accept the slate of deacons, elders and nominating committee as presented. All were in favor, motion passed.

That ended the business of the meeting. Rev. Burslem closed the meeting with prayer.

<u>First United Presbyterian Church Congregational Meeting</u> Sunday August 20, 2023

Rev Robert (Bob) Wade moderated this congregational meeting. A motion, second and vote was called to elect Elder Bridget Hawkins as the recording secretary Pro Tem due to the absence of Clerk of Session, Karen Brady. Motion approved.

Moderator Wade opened the meeting in prayer and shared the purpose of the meeting: To vote on the session's recommendation to concur with Rev. Merrin's request that the Presbytery of the Miami Valley dissolve the pastoral relationship between himself and First United Presbyterian Church, Bellefontaine, effective August 31, 2023, and to agree to the negotiated Dissolution Agreement.

This is the only business that can be considered at this meeting.

Beth Powers presented the motion to the congregation:

The session moves that the congregation of First United Presbyterian Church approve the following actions in one vote:

Concur in the request of Rev. Steve Merrin to request that the Presbytery of the Miami Valley dissolve the pastoral relationship between himself and the First United Presbyterian Church, Bellefontaine, effective August 31, 2023. Agree to the negotiated Dissolution Agreement presented by the session.

At a meeting held on August 8, Rev. Steve Merrin and the session agreed to a mutual separation. Both the congregation and the presbytery have roles in ending the pastoral relationship as Pastor Steve and the session have mutually agreed upon, and today is when the congregation votes to approve or disapprove this mutual request.

Rev. Merrin and the session have successfully negotiated an equitable resolution, including a financial settlement, that the session also presents to the congregation for approval today. The five-month period of continued salary and benefits, which includes unused 2023 vacation and continuing education leave, in the Dissolution Agreement is reasonable and consistent with dissolution packages approved at other churches. The two parts of the session's motion are voted on together as one package because they represent a unified approach to an appropriate dissolution for Rev. Merrin and the congregation.

Clarification of process by the Moderator:

While the congregation is free to debate the session's motion today, the dissolution agreement may not be amended by the congregation because it is a carefully negotiated set of provisions between the session and the Pastor. Each congregation member's vote will either be Yes or No on both elements of what the session has presented. Only active members of this congregation may vote and no absentee or proxy votes are permitted.

Let me be clear, this is NOT a vote For or Against Rev. Merrin. This is a vote on whether or not to concur with the mutual agreement to end the pastoral relationship and to provide him with ongoing financial support through January 31, 2024

A majority vote of Yes will approve the motion. If a majority of the congregation were to vote No on the session's motion, the Book of Order requires that the Presbytery of the Miami Valley hear from

the congregation as to the reasons why the presbytery should not dissolve the pastoral relationship as the pastor has requested. Then the presbytery decides whether the pastor's request to dissolve should be accepted.

Questions?: Mark Butler responded to questions concerning when we could begin the process for a new minister. The process for a self-study concerning the wants of the congregation and for a new minister can begin at the September 21 Session meeting.

Financial terms are as follows:

Provide compensation including salary, housing allowance and Medical Supplement through January 31,2024 at the rate currently set in the most recently approved terms of call. Specifically, salary of \$3158/month, and housing allowance of \$2067/month shall be paid every two weeks on the regular pay schedule. These payments shall cease if Rev. Merrin secures another full-time position. Provide full Board of Pensions' pension contributions, family medical insurance coverage, and disability insurance coverage all based upon Rev. Merrin's total effective salary through January 31,2024, making such payments as necessary to the Board of Pensions on Rev. Merrin's behalf. These payments shall cease if Rev. Merrin secures another full-time position. Reimburse Rev. Merrin for all properly approved automobile, professional and continuing education expenses accrued through August 31, 2023.

Reverend Merrin made a brief statement and then he and Andrea Merrin exited the sanctuary for the vote.

Discussion on the Motion: One question was asked and clarified by a member of session.

Distribution of Ballots: Bob Day and Cindy Jenkins served as tellers and distributed ballots to 1st UPC members and collected them after voting, under the supervision of COM members.

While votes were being tallied, Moderator Wade shared the length of severance packages within the Presbytery from 2007-2022, with our package being comparable to other severance packages agreed upon during that time period. The recorded vote was 39 yes votes and 5 no votes. This vote dissolves the relationship between Pastor Merrin and the 1st UPC congregation. This vote was recorded onto tally sheets, signed by Cindy Jenkins, Bob Day and COM members Scott Risner and Brenda Peters. The ballots and tally sheets were returned to Moderator Wade, who announced the results and provided tally sheets to Rev Merrin and Session Member Anne Brienza, with COM retaining the 3rd copy.

The Resolution will be finalized by the Commission On Ministry in the coming week. The Session will host a coffee hour for the Merrin Family Sunday, August 27, 2023.

Motion to adjourn was made by Pat Ortli, 2nd by Edson Jenkins, and passed by voice vote. Moderator Wade closed the meeting in prayer.

BY-LAWS OF THE CONGREGATION AND CORPORATION OF THE FIRST UNITED PRESBYTERIAN CHURCH Bellefontaine, Ohio

SINGLE BOARD – UNICAMERAL SYSTEM

- 1. The First United Presbyterian Church of Bellefontaine, Ohio, being a particular congregation of The Presbyterian Church (U.S.A.) recognizes that the Constitution of said Church, is in all its provisions, obligatory upon it and its members.
- 2. There shall be an annual meeting of the Congregation & the Corporation in the Church Edifice during the month of January for the transaction of any business properly coming before such meeting. Said meeting date will be set by the Session no later than its preceding December meeting.
- 3. There shall be an special additional annual meeting of the Congregation in the Church Edifice the third week month of October for the purpose of (a) receiving the report of the Representative Nominating Committee; (b) electing the new class of Elders and Deacons and the congregation-at-large representatives to the Nominating Committee; and (c) receiving a report from the Stewardship and Finance Committee concerning the annual Stewardship Campaign.
- 4. Public notice of the time, place and purpose of all meetings of the Congregation shall be given at least one week prior to the appointed time, so that the call of a Congregational meeting shall be made twice before the Congregation.
- 5. The Pastor shall preside at all meetings of the Congregation. If the Church is without a Pastor, or if the Pastor and the Ruling Elders agree that the subjects to be discussed require it, or if the Pastor is ill or is otherwise unable to be present, a Minister of the Miami Presbytery shall be invited by the Session to preside. This invitation shall be cleared through the Committee on Ministry of the Miami Presbytery.
- 6. The Clerk of Session shall be Secretary of the meetings of the Congregation. If unable to attend, the Session shall designate a Secretary in the Clerk's stead.
- 7. The members of the Church shall be active members in good standing as defined by the usages and rules of <u>The Presbyterian Church (U.S.A.)</u>, regardless of age.
- 8. As required by the laws of the State of Ohio, only members of full age 18 years shall be eligible to vote on questions dealing with property and matters that are strictly the business of the Corporation. Otherwise, all active members of the church are eligible to vote at all stated and special meetings of the Church. Voting by proxy is not allowed.
- 9. Meetings shall be conducted in accordance with Roberts Rules of Order as adopted by the General Assembly of <u>The Presbyterian Church (U.S.A.)</u> so far as they apply, and when they do not apply, according to usual legislative rules of order.
- 10. All meetings shall be opened and closed with prayer.
- 11. A quorum shall consist of the Moderator, Secretary and 10 percent of the eligible voters.
- 12. The Session shall be comprised of the Ruling Elders of the church. There shall be no less than nine (9) and no more than twelve (12) Elders as recommended by the Nominating Committee and approved by Session. The Elders shall be divided into three equal classes, with 3 to 4 Elders in each class, one class of

whom shall be elected each year at the October meeting for a three-year term. An Elder shall be elected to serve terms of no more than 3 years and may be eligible for re-election but may not serve more than 6 consecutive years. A Ruling Elder who has served 6 years shall be ineligible to the same board for at least one year.

- 13. There shall be no less than nine (9) and no more than twelve (12) Deacons as recommended by the Nominating Committee and approved by Session. The Deacons shall be divided into three equal classes, with 3-4 Deacons in each class, one class of whom shall be elected each year at the October meeting for a three-year term. A Deacon shall be elected to serve terms of no more than 3 years and may be eligible for re-election but may not serve more than 6 consecutive years. A Ruling Deacon who has served 6 years shall be ineligible to the same board for at least one year.
- 14. Vacancies on the Session or the Board of Deacons may be filled at a special meeting of the Congregation or at the annual meeting, as the Session may determine.
- 15. The Ruling Elders of the church shall serve as the Trustees of the Corporation. There shall be 12 trustees divided into three equal classes, one class of whom shall be elected each year at the October meeting for a three-year term. Only a person elected for a term on the Session shall be eligible for election for a term as trustee, and when such qualified person is elected as trustee, he or she shall serve only for the duration of the term for which elected as member of the Session.
- 16. The Session acting as Trustees for the Corporation shall report annually to the Congregation:
 - A. The receipts and payments for the previous fiscal year
 - B. The estimate of expenses and income for the year ahead.
 - C. New business necessary to be undertaken for the welfare of the Congregation.
 - D. An exhibit of the real property, trust funds and other resources of the Congregation.
- 17. The Chairperson of the Stewardship and Finance Committee shall serve as President of the Corporation and the Board of Trustees of the Church Corporation and the Clerk of Session shall serve as Secretary to the Corporation and the Board of Trustees of the Church Corporation.
- 18. A quorum for Session meetings shall be as provided in the Form of Government; a quorum for the transaction of business as Trustees shall be a majority of the Trustees then in office.
- 19. There shall be a Representative Nominating Committee chosen in accordance with the Book of Order. The Committee shall bring to the October special meeting nominations of one eligible person only for each office to be filled. Additional nominations of qualified persons may be made from the floor by an eligible voter provided that the permission of the person being nominated has been secured in advance.
- 20. These By-Laws may be amended subject to the charter of the Corporation, the laws of the State of Ohio, and the Constitution of <u>The Presbyterian Church (U.S.A.)</u> at any annual meeting, or at any special meeting, by a two-thirds (2/3rds) vote of the voters present provided that a full reading of the proposed changes or a printed distribution of the same shall have been made in connection with the call of the meeting.
- 21. These By-Laws or the Charter of this Corporation may not be amended contrary to or so as not to include the provisions of the Constitution of <u>The Presbyterian Church (U.S.A.)</u>

The beginning balance as of January 1, 2023 was \$2,900.59.

The Deacons received funds throughout the year from 1st. UPC mission funding, 2 cents for compassion, and other private donations totaling \$3,651.99.

The Deacons made payouts throughout the year totaling \$2,995.98. These payouts included the following: Kirkmont Center for camperships earned through the Building Blocks Program. We also supported, by donations, the following organizations: the Presbyterian Disaster Assistance Program, The Logan County Family Court Treatment Program, Kirkmont Center, and funded a school classroom day at Kirkmont. We assisted several congregants with hardship issues as well. In addition, we reimbursed expenses incurred for postage, funeral dinner items, and Christmas florals for our homebound members.

Our ending balance as of December 31, 2023 is \$3,556.60.

For 2023, team members include Bridget Hawkins – Chair, Mike Brady – Elder, Sue Dearwester – Church Treasurer, Jim Hilliker, Gary McKenzie, Warren Taylor. This team is staffed by Church Financial Secretary Holly VanBuskirk.

The Annual In-House Audit was performed on February 18, 2023, reviewing the records for the year 2022. Everything was found to be in good order and well organized. No items of concern were found.

The team continued to meet monthly throughout the year. There was always a review of financial reports from the various committees that are funded by the Church and found expenses are within the budget. The team compared actual income and expenditures with the budget. Those numbers were then reported to Session at each of their meetings.

Our Stewardship Campaign for 2024 began October 15, 2023. We want to continue to be an active church and our total pledging for 2024 is as follows:

41 pledges received totaling \$123,800.00.

- 10 pledges remained the same totaling \$22,800.00.
- 18 pledges increased totaling \$77,640.00.
- 11 pledges decreased totaling \$21,280.00.
- 2 pledges are new totaling \$22,080.00.
- 12 pledges were not renewed totaling \$65,997.00.

In comparison to 2023, total pledges for 2024 were down \$54,000. The prior year pledges are listed as follows:

The budget for 2024 has been set and approved by Session, based on income from our Pledgers, projected numbers from Non-Pledgers, the Loose Offering, Sunday School Offering, funds from the Endowments, and income from outside sources renting the Fellowship Hall. This year we are hopeful and confident that support from our church will be strong.

The Endowment Fund Committee is responsible to receive donors' gifts to the church, insure that the wishes of the donors are honored, and to invest those funds with a priority of principal preservation and competitive interest return. To implement this conservative investment philosophy, the Committee, over the past twenty-six years has consistently invested the majority of the Fund in medium and long-term United States Government Bonds and high grade municipal bonds. This has provided a steady interest return and insured principal preservation. Beginning in 2013, the Committee expanded its conservative bond investment philosophy to include high-grade, AAA rated, general obligation municipal/county/state bonds. The same quality high-grade corporate bonds are also approved for investment.

During 2023, the Endowment Fund earned an average of 3.16% interest. This is comprised of 3.81% for funds under the investment management of the Committee, and 3.06% for gifts of specific assets.

Programs supported by the Fund's interest continue to include the church's Sharing Fund, our Christian Education Program, and the Scholarship Program of our church. \$13,000.00 was granted to college scholarship recipients in 2023.

Gifts can be donated to our church through the Endowment Fund in three ways: 1.) restricted principal and restricted interest, 2.) restricted principal and non-restricted interest, 3.) non-restricted principal and non-restricted interest. All members of the congregation are encouraged to use the Endowment Funds to make contributions that will provide long-term benefit to the program life of the church.
